

## *Conditions of joining the Association members*

Members of the Association may be legal entities, unions, associations, public associations, foundations, other non-profit and commercial organizations, the activities of which do not contradict the goals and subject matter of the Association.

Admission to the Association is carried out by the decision of the General Meeting of Association members on the basis of a **written application of a legal entity to the Chairman of the Association** and **payment of the entrance fee** (paragraph 14 of the Charter of the Association).

### **I. List of documents required upon joining the Association:**

- 1) written application of a legal entity addressed to the Chairman of the Association (*standard form attached*);
- 2) a document confirming the payment of the entrance fee. The amount of the entrance fee for organizations joining the Association is 100 000 (one hundred thousand) tenge.
- 3) copy of the charter of the legal entity;
- 4) a brief description of the activities of the legal entity wishing to join the Association (*preferably in Russian and English*);
- 5) copy of the certificate of state registration (re-registration) of the legal entity.

**III. The amount of the annual membership fee is as follows:**

- 1) in the amount of 6,000,000 (six million) tenge - for the main part of members;
- 2) in the amount of 500,000 (five hundred thousand) tenge - for subsoil users engaged in exploration of hydrocarbons;
- 3) in the amount of 3,000,000 (three million) tenge - for oil companies producing oil up to 50,000 tons per year inclusive;
- 4) in the amount of 6,000,000 (six million) tenge - for oil companies producing oil from 50,001 to 100,000 tons per year inclusive;
- 5) in the amount of 10,000,000 (ten million) tenge - for oil companies engaged in oil production from 100,001 to 5,000,000 tons of oil per year;
- 6) in the amount of 15,000,000 (fifteen million) tenge - for oil companies producing more than 5,000,000 tons of oil per year;
- 7) in the amount of 15,000,000,000 (fifteen billion) tenge for national companies (NC “KazMunayGas” JSC “KEGOC” JSC, NAC “KazAtomProm” JSC, National Company “QazaqGaz” JSC and strategic energy holding (“Samruk-Energo” JSC);
- 8) in the amount of 3,000,000 (three million) tenge - for organizations with the main activity in the field of ecology, nature management, renewable and alternative energy sources;
- 9) in the amount of 2,000,000 (two million) tenge - for organizations of higher and (or) postgraduate education and scientific organizations.
